NGO'S:-

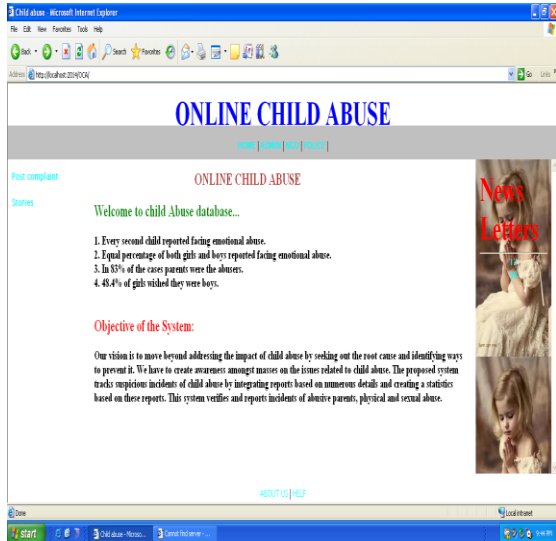
A regular news letters shall be sent to the registered users(NGO'S, investigation agencies & other users). Ngo's in our system caputers the information from admin and they poists news letters.
