This Module deals with the Law part of every crime.

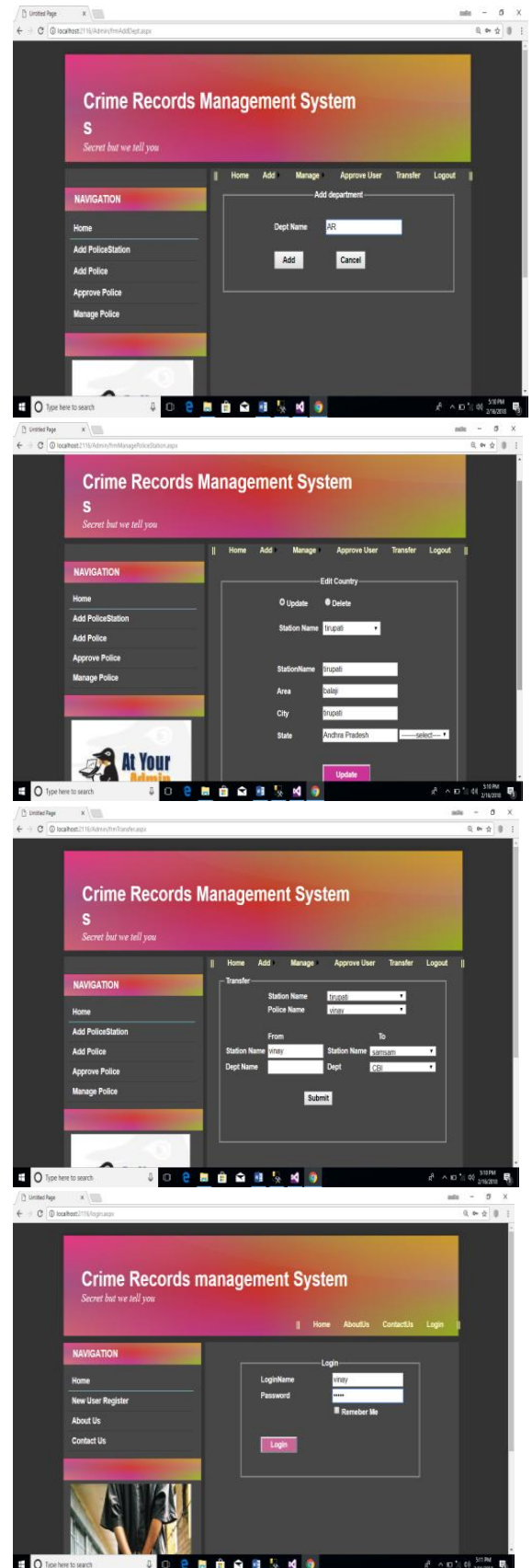
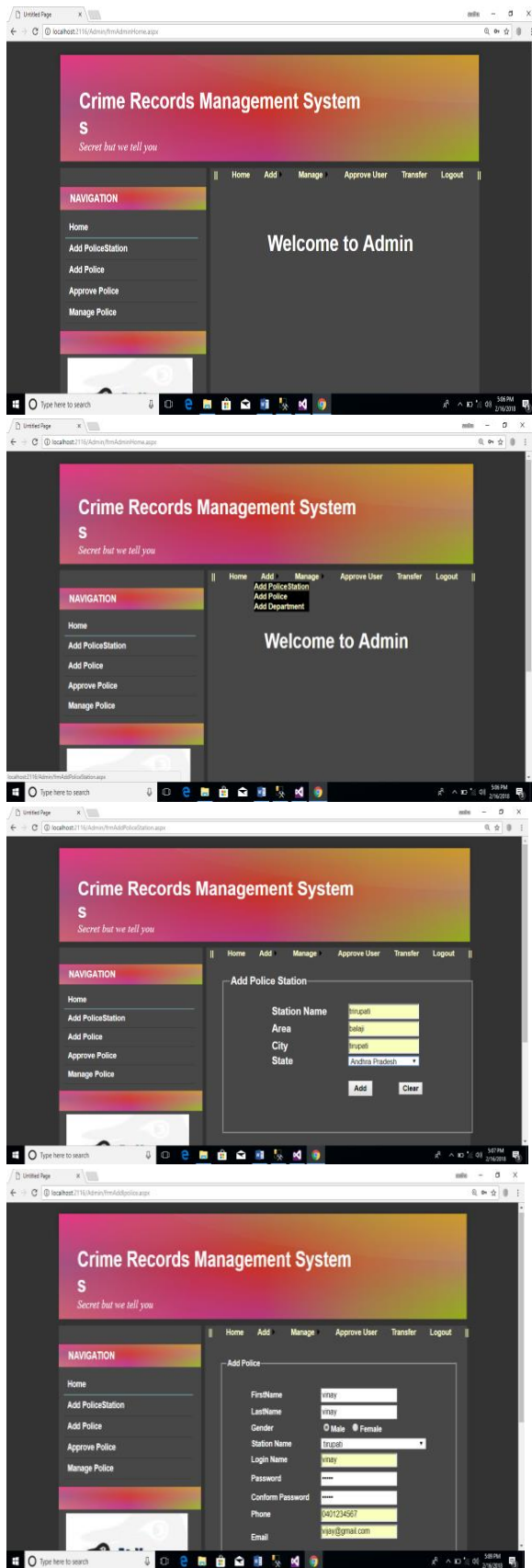
