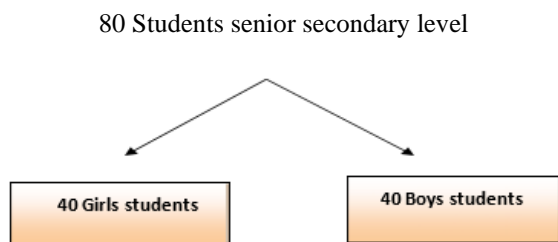
## Objectives

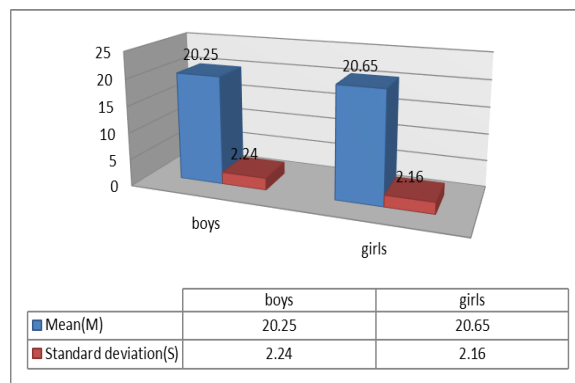


Fig- Opinion of students studying at boys and girls at secondary level through online mode.
