These teams play against each other to accumulate points during real life match. The winners are decided and declared on the basis of these points only. It is predominantly an online prediction game. It refers to online games where people make virtual sports teams and take part in contests and other leagues that imitate the actual world games. There are virtual teams picked from a pool of real players. People exhibit their knowledge, perception and experience of actual players and it is only after accumulating thorough knowledge that they pick their teams. As per a recent report published about Fantasy Sports by Federation of Indian Fantasy Sports and KPMG, the gross revenue generated from these sports stood at Rs. 2400 Crore (US \$ 340.47 million in 2020 which is expected to rise upto US \$ 3.7 billion by 2024. Thus Fantasy Sports has become a big Industry in India with an increase of 2500% in the number of Fantasy sports users during last decade. More and more multiple operators are emerging with their novel ideas and offerings. But it is imperative to have a government to look after and monitor this multi billion industry.

It needs to be mentioned that complete market of this Fantasy sports stands in a grey area so far as regulatory concerns are concerned. There is absolutely no concrete legislation for its legality. Questions were raised whether Fantasy sports are gambling or Game of Skill. As per 7th Schedule of the Constitution of India gambling is a State issue and only the states can form any regulatory body regarding this. Presently, there is no centralized legislation to look after Fantasy sports in India. States of Goa and Sikkim don't prohibit gambling. Odisa, Assam, Tamilnadu, Telengana, Nagaland and Andhra Pradesh have put restrictions on Games of Skill also. Therefore, people

of these states cannot participate in Fantasy sports like Dream 11 and others. In fact there have been a lot of decisions by different courts that Fantasy sports are Game of Skills. The matter was first taken up by Punjab and Haryana High Court that ruled that Dream 11 like games are primarily based on skill. The court cited a number of reasons for the same. The Supreme Court in 2020 gave a stay against the order of Bombay High Court saying that Fantasy sports are Games of Skill. But in August 2021, Supreme Court of India upheld the legality of Fantasy sports. It was against the decision of Rajasthan High Court. Come what may, there is no doubt that there is an urgent need of central legislative framework to remove ambiguity. However Advertising Standards Council of India has come up with some guidelines with regard to the advertisements of Fantasy sports and online gaming. The FIFS safeguards consumer interests. Actually, the growth and sudden spurt in Fantasy Sports in India owes its origin in the growth of Internet in India. High speed Internet service is required for these fantasy sports which are going to take much needed boost with the arrival of 5G Internet facility in India. Though these sports fall just short of money betting but they need skills also.

Just like financial, shopping, banking, food, travel and news apps there are so many Fantasy sports apps available to the people. Game of War, Clash of Clans, 8 Ball Pool, PUBG, FIFA Football, My11Circle, Dream League Soccer, My Team11, Idle Minor Tycoon, Howzat and Ludo Club etc. are some of the popular Fantasy sports. These games have the capacity to captivate people for longer periods of time.
