Published in 1969, this autobiography chronicles Angelou's early life, from her tumultuous childhood in the Jim Crow South to her adolescence and coming-of-age experiences. Through her vivid prose and unflinching honesty, Angelou invites readers into the depths of her personal journey, navigating the complexities of race, trauma, and self-discovery.

Her first Autobiography involves a progression from anger and resentment to subtle confrontation to a vigorous demonstration. This progression offers Caged Bird a thematic unity that contradicts the episodic structure of the narrative. To claim thematic unity is to suggest that form and content work together, a statement that is an aversion to contemporary literary theory. Nevertheless, the formal in Caged Bird is the vehicle of the political messages she wants to pass. The structure of the narrative encompasses episodes that are created much like short stories, and their organization throughout the Autobiography does not at all times include a strict chronological order. Nonetheless, an Autobiography has not to be necessarily chronological, but an anticipation of chronological order from the reader's part is normal, therefore Caged Bird includes this element and in the very beginning the narrative starts with earliest memories such as with the scene where the 'powhitetrash' girls insult Maya's grandmother (Wall, 2014, p. 7).

The 'Caged Bird' was investigated by Emmanuel, (2017) as well, to identify the psychodynamic processes present in the Autobiography . According to the researcher the nuclear family's concern at mentoring the child is optimal. In 'Caged Bird ', Angelou was banished and alienated from the parents during her pre-Oedipal periods. Therefore, as the child did not detach in a successful way from her crucial unity with the parents, they were not originally able to shape self-boundaries and proper mental representations. Thus, Maya in 'Caged Bird ', turn out to be cold, detached and discouraged. She, as a result, came across various challenges in her new

environment. Maya's normal drive for a father-figure, at the stage of Oedipus complex traps her into the hands of Mr. Freeman who at last rapes her. The ego forces her to escape from the early relationship with her father that forced her to overcome her delicate selfboundaries. The protagonist was controlled by her id as she desired matters that never fully pleased her cravings. It's worth mentioning that Maya's wish for sexual intercourse with an adolescent boy leads to a teenage pregnancy. Lastly, she was ruled by her superego and guided by Momma and Aunty Ifeoma who helped her pass into adulthood, forming a successful gender identity while taking responsibility for her actions within society. Furthermore, the family unit which is the core of human relationships should be protected carefully to transcend divorce and violent behaviors, in other words, it contributes to protect the future generations from the creepy and disturbing situations with the aim to help children grow up peacefully and harmoniously (Traylor, 2014, p. 2).

Angelou as a Black woman and a writer who differentiates herself by infiltrating her artistic work with steady cultural awareness, and individual and racial experience. Her verse discloses subjects related to the survival, growth and self-consciousness of African American people. Angelou appears to uncover the critical consequences associated with the hegemony of the White Anglo-Saxon Protestant culture which had been exploiting and excluding the African American people. Angelou intensely wants to challenge the twofold antagonism of the leading and subaltern cultures and restructure the social order. She tries to redefine Blackness and eulogize the acceptance of Black people. Angelou inspires African American people to take over their African traditional heritage and support their Black self (Du, 2014, p. 66). Nonetheless, a study by Sunday & Ekpo, (2018, p. 45), reveals that although African American women suffered immensely as a consequence of their unprivileged position related to race and gender, their pliability at copying and resisting remained intact. The way Maya employs imagery and symbolism in her literary work creates an exceptional and loudmouthed linguistic ethos of African American women. Possibly Angelou's ultimate impact is associated with the fact that she combines history with poetry. Angelou's concentration lied on filling the 'most dull, most ordinary' with the historical past and its figurative reflections in her poetry (Tucker, 2014, p. 92, Koyana & Gray, 2007, p. 3).

Her Autobiographies uncovered subjects that were hidden. In her Autobiographies, the protagonist's emotional state was as central to the narrative as the events it included (Neubauer, 1983, p. 126). There was no Autobiography of a Black woman before the publishing of Caged Bird which exposed as much of its writer's inner life and experience. Angelou's uprightness paved the emotive link between the author itself and the readers. In the following volumes of her Autobiography, readers follow Angelou on her wandering across the world (Wall, 2014, p.4).

These words reflect the passage of time and temporal context throughout the chapter.

Words associated with space include "Arkansas," "North," "Beach," "United," "Stamps," "South," "States," "Long," "Arizona," "Blacks," "California," and "the." These words denote various locations mentioned in the narrative, contributing to the spatial context of the events described.

The sentiment score for the chapter is 0.018, which suggests a slightly positive sentiment overall. The sentiment score of 0.081 indicates a slightly positive overall sentiment in this excerpt. This sentiment reflects the resilience and strength that Angelou demonstrates throughout her autobiography, despite the obstacles she faces.

In the last Chapter of Maya Angelou's autobiography "Caged Bird," the temporal references provide insights into the passage of time and the sequence of events in her life. These references include phrases like "eons," suggesting an indefinite, vast period, and "three months," indicating specific а timeframe. Additionally, phrases such as "Some years before" and "only years later" denote events occurring at various points in the past relative to the narrative. The mention of "weeks" and "months" further delineates shorter durations within Angelou's experiences. Moreover, specific dates or events, like "V-Day," mark significant moments in her life journey.

Regarding locations, the text mentions "South America," indicating a geographical reference to a specific region. These spatial references contextualize Angelou's experiences and provide insight into where certain events take place within her narrative.

The word associations in the text reflect the thematic elements and recurring motifs present in Maya Angelou's autobiography "Caged Bird." Words associated with time include terms like "sixth," "evening," "eight," "minutes," "later," "eons," "days," "hours," "weeks," "years," "before," "old," "week," "or," "next," "only," "month," "my," "fourth," "three," "one," "night," "Some," "Day," "Two," "four," and "the." These words collectively evoke a sense of temporal progression, marking specific moments, durations, and sequences within Angelou's life story.

On the other hand, words associated with space include "South," "America," "Mornings," "Alaska," "San," and "Francisco." These spatial references provide context for the settings and locations where various events unfold in Angelou's narrative, grounding the reader in the physical environment and geographical landscapes that shape her experiences.

Together, these word associations contribute to the rich tapestry of Angelou's autobiography, weaving together the threads of time and space to create a vivid portrayal of her life journey and the environments in which it unfolds.

The analysis of Maya Angelou's autobiography "Caged Bird" using natural language processing (NLP) methodology reveals significant insights into the temporal, spatial, and emotional dimensions of her narrative.
