The reader, much like Maya, experiences the narrative in a fragmented manner, reflecting the difficulty Maya faces in crafting a coherent narrative of her own identity. This disjointedness creates a sense of unease and further emphasizes the fragmented nature of Maya's sense of self.

The trauma she faced includes her past abuse and racism along with unresolved childhood trauma that she received as a child from her father. Her relationship with her father is both a connection and a conflict. As a child, she always wished for his love, but she would get nothing, and his decision to remarry made her expose the potent mix of betrayal and resentment. His impending marriage acts as a catalyst, releasing her suppressed emotions. "Two decades of bottled-up hate finds an outlet. Kandasamy (*Exquisite Cadavers* 19), indicates a long-standing resentment towards her father. This anger likely stems from her childhood experiences of abandonment and her perception of his role in her mother's departure.

Maya being very close to her father since childhood though she received very less parental love from him made her describe paternal obsession as untranslatable disease and views her father's behaviour as pathological. She sees his focus on his new relationship as a form of obsession, further fueling her resentment and sense of abandonment. This idea of obsession is perceived by her as "contagious state-ofmind" and that will negatively impact her own life and relationships. "Paternal obsession is an unnamed, untranslatable disease marked only by how it leaves behind a contiguous state-of-mind. "Kandasamy (Exquisite Cadavers 20). This impact of past trauma relating to her father on Maya's present sense of self is a recurring theme, becoming a strong reason for her fragmented self.

THE SCARS OF RACISM: IMPACT ON IDENTITY

Kandasamy powerfully illustrates the theme of racism through the experience of Maya, a mixed-race woman whose life is significantly altered when she enters a relationship with an Arab man. Before her relationship, Maya's mixed-race heritage allowed her to "pass for white," granting her certain privileges and shielding her from questions about her origins. The introduction of an Arab partner disrupts this, suddenly making her racial identity a subject of scrutiny and prejudice. This demonstrates how racial categorization is not fixed but can be fluid and context-dependent. Meena kandasamy uses the phrase "lets loose everyone's inner Orientalist" which directly refers to the concept of orientalism which describes the West's exoticizing and often prejudiced representations of the East. Since Maya's relationship has made her a representative of her partner's race and culture. She anticipates the prejudiced questions and comments, recognizing that engaging with them would be emotionally draining and makes her a representative of her partner's race and culture. This performative self-deprecation can be a way of deflecting criticism or appearing tolerant, while simultaneously perpetuating harmful stereotypes. By laughing along with the jokes, Maya may inadvertently internalize some of the racist sentiments they express. This can lead to feelings of self-doubt, shame, and a distorted sense of her own identity. Kandasamy powerfully illustrates the theme of racism through the experience of Maya, a mixed-race woman and her experience exposes the pervasive and insidious nature of racism, highlighting how it operates through stereotypes, microaggressions, and the constant questioning of belonging that further lead to fragmneted identity. Maya frequently revisits past traumas and anxieties, particularly those related to her childhood and her mixed-race heritage. These

cyclical thoughts, while not exact repetitions of events, trap her in a loop of unresolved emotions, preventing her from moving forward and forming a cohesive sense of self.

The constant return to these themes underscores the fragmented nature of her memory and the difficulty she faces in integrating her past experiences into her present identity. While not as prominent as the ruminations, certain behavioral patterns, like seeking validation from others or withdrawing into isolation, can be seen as manifestations of repetition compulsion. These behaviors, though seemingly different, stem from the same underlying anxieties and contribute to a sense of stagnation in Maya's personal growth. Along with this, the novel's fragmented structure, with its abrupt shifts in time and perspective, mirrors Maya's fragmented internal state. This formal choice reinforces the sense of disruption and discontinuity that characterizes her experience. The recurring motifs and themes throughout the narrative further emphasize the cyclical nature of Maya's thoughts and the challenges she faces in creating a coherent narrative of her own life.
