Abstract— Vitiligo (Leucoderma) is a chronic autoimmune pigmentary disorder affecting approximately 2–5% of the global population. The exact etiology remains unclear; however, increasing evidence supports an autoimmune basis involving melanocyte destruction. This clinical study presents a 28-year observational analysis conducted at Anand Hospital & Research Centre, Ghodegaon, assessing the efficacy of immunomodulatory homoeopathic therapy in repigmenting skin and restoring melanocyte activity. Over 7,000 patients worldwide achieved significant clinical recovery without the use of steroids, UV therapy, or invasive interventions. II. AIM AND OBJECTIVES

Aim: To clinically evaluate the role of immunomodulatory homoeopathic therapy in the management and repigmentation of Vitiligo.
Objectives:

1. To assess improvement in pigmentation and arrest of new patch formation.
2. To evaluate changes in immune response through clinical observation and clinical assessment
3. To provide a low-cost, non-invasive, and safe management model suitable for rural populations.

III. MATERIALS AND METHODS

V. DISCUSSION

This long-term study suggests that homoeopathic remedies act through immunomodulation balancing Th1/Th2 cytokine activity, reducing autoimmune aggression, and promoting melanocyte regeneration.
